I, the undersigned subscriber to cable television services from Kuhn Communications, Inc. (hereinafter referred to as "KCI"), agree and understand that the property which I am now receiving as shown on this agreement (hereinafter collectively referred to as "the Property") is and remains the property of KCI. I understand that I may cancel my subscription at any time following the first calendar Month for which I received these additional cable television services by requesting that the property be removed from my premises. I acknowledge I must make an appointment for the removal of the property within five (5) days of my cancellation notice and that I am obligated to pay for these services until the property is removed by KCI or equipment returned to office.

I agree to take proper care of the property including replacement of batteries when necessary and understand that I am responsible for reasonable repair charges (as determined solely by KCI) if the property is damaged while under my control. I realize I am completely responsible for returning the property to KCI in the same condition as I received it when my subscription is terminated regardless of any event which has occurred including acts of God.

If I am unable to return the property to KCI in the same condition as I received it for whatever reason, I agree to pay the amount shown below in liquidated damages to KCI and, in addition, agree to pay whatever costs, if any, KCI incurs in recovering the property. I acknowledge that there are seals on the property to prevent tampering and the seals are intact as I receive the property. I agree that I will not tamper or otherwise attempt to open the property. I also understand that if I attempt to tamper with, open or insert material into or do anything that disturbs the normal working process of the property, I have violated this agreement and am subject to the same amount checked below and cost terms in the same manner as if I had failed to return the property to KCI. I agree this is the true and correct value for the property. I understand that my liability does not extend to technical malfunctions of the property which are beyond my control. I agree that should the property not work properly, I will not attempt to fix it, but will notify KCI of any malfunction.

I understand that if I am more than TEN (10) days delinquent in the payment of the monthly charges for cable services, as provided herein, that I run the risk of having these services terminated until payment is made. I consent that representatives of KCI may enter any premises owned or leased by me for the purpose of verifying, maintaining or discontinuing cable television services and removing the property.

If I have paid a security deposit, the amount is shown above. If no deposit is paid, I have furnished a valid credit card for the billing of the amount of the property if the terms of this agreement are not fulfilled. I also acknowledge that if equipment not returned within ten (10) days of disconnect, credit card will be charged. I acknowledge if deposit made this is not a deposit for future cable television services, but is a security deposit for the property. Accordingly, I realize that KCI will not apply the deposit toward my cable television service fees unless the property is returned in a condition satisfactory to KCI. I acknowledge I will receive the amount of the deposit without interest when the property is safely returned to KCI, unless I owe KCI for services. I understand KCI may cancel this agreement and remove the property upon notice to me.
